RULES OF THE EVENT:

1. Return application and booth fee by **MAY 2, 2024**. Vendors provide their own tables, chairs, extension cords, etc. **Booth assignments are numbered in a first come first serve basis.** A vendor representative should be present at Kiwanis Park at the time of the booth space assignment. Assignment will be Friday, May 3, 2024, at 4:00 p.m.
2. *Vehicles must be removed from inside the park by 10:00 am on Saturday once unloading is completed.*
3. Inappropriate advertising or any type of non-vendor advertising is forbidden during the event.
4. Handcrafts, antiques, food are welcomed. Garage sale items are not permitted.
5. Electricity outlets (110v) are available on first come first serve basis. *One plug available per booth!*
6. *Vendors must remain at their booths till 5:00 p.m. You may disassemble booth promptly after 5:00 p.m.*
7. One business per booth. If more than one, each business will pay a booth fee.
8. Food vendors are required to have a temporary health/food permit from the Angelina County Health Department. Contact them at: acchd.us click on: *I need help with...*, click on: *Applying for a Food Establishment Permit...*, click on: *Temporary Event Permit Application...*, or call 936-632-1139.

PLEASE NOTE THE FOLLOWING:

- Fees are NON-REFUNDABLE regardless of circumstances.
- Fees are donated to Communities Cinco de Mayo and are *tax deductible*.
- *This is a benefit fundraiser event!* Duplication of booths is permitted.
- A \$20 clean-up deposit fee per booth is required. Fee is refunded if space is thoroughly clean at the end.
- *Sponsors, City of Lufkin, volunteers, or CCDM shall not be held responsible for loss, accident or injury.*
- Booth spaces are approximately 20'x10'. Make check payable to: Communities Cinco de Mayo.
- Provide information about your awnings, tents, trailers, etc., so we can place you accordingly.
